1. Item #1 was presented by Avi Kaner. Upon motion by Helen Garten, seconded by Jim Marpe and passing by a vote of 3-0, it was:

RESOLVED, that the minutes of the Board of Selectmen's public hearing of September 28, 2016 are hereby APPROVED.

<u>UPDATE ON ADAPTIVE RE-USE FEASIBILITY STUDY REPORT RELATED TO</u> GOLDEN SHADOWS

2. To receive an update on the Adaptive Re-Use Feasibility Study Report as it relates to the Town owned property located at 68 Compo Road South (a/k/a Golden Shadows.

Item #2 was presented by Architect William Achilles. Mr. Achilles provided an overview of his findings. He summarized the presented report including an update to the mechanical systems, planning and zoning factors related to each potential use, road access, and possible costs involved with updating and refurbishing the space. Members of the public spoke and provided opinions. There was no action taken by the Board.

3. Item #3 was presented by Chair of the Historic District Commission Francis Henkels. Mr. Henkels provided the history and background of the Report. Assistant Town Attorney Gail Kelly provided the legal background and current status of the designation process for this particular Town property, including reviewing the results of the recent RTM meeting. Mr. Lindsay described the procedure that the vendor will use to keep the property safe, accessible and useable into the future, as well as maintaining the health of the forest. Assistant Town Attorney Gail Kelly will insure that adequate insurance liability requirements are met and will be included in the final agreement. 7. Item #7 was presented by Parks and Recreation Director Jennifer Fava. Ms. Fava noted that the amount on the original memo to the Board should be corrected to reflect only the contract amount of \$41,000. Upon motion by Helen Garten, seconded by Jim Marpe and passing by a vote of 3-0, it was:

9. Item #9 was presented by Director of Public Works Steve Edwards. Mr. Edwards explained the NOVAchip process that will be used to extend the pavement life on selected Town roadways. Upon motion by Helen Garten, seconded by Jim Marpe and passing by a vote of 3-0, it was:

RESOLVED, that the award of contract to The Gorman Group, LLC as it relates to the NOVAchip paving application on various Town roadways is hereby APPROVED.

APPROVE INSTALLATION OF CROSSWALKS ON IMPERIAL AVENUE AT BAKER AVENUE AND THOMAS ROAD INTERSECTIONS

10. Item #10 was presented by Director of Public Works Steve Edwards. Mr. Edwards explained that with the newly constructed sidewalk on Imperial Ave, the crosswalk designations were now required. He indicated that appropriate signage would be installed. The Board

RESOLVED, that acting in its capacity as the Traffic Authority, the installation of crosswalks on the Town-owned roadway known as Imperial Avenue at its intersections at Baker Avenue and Thomas Road are hereby APPROVED.
