 - a. Motion to approve by J. Hartwell, second by B. Stern Vote 5-0-0 (Rea abstained)
- 2. Financial Report from the Finance Director. (Discussion Only)- No Vote
- 3. Status Update from the Audit Manager. (Discussion Only)- No Vote
- 4. Heard the request of the Conservation Director, to approve a transfer in the amount of \$700 from the Vehicle Maintenance Account # 10101182-543000 to the Fees and Services Account # 10101182-531000 to cover expenses for wetland boundary flagging. No Vote necessary.
- 5. Approved the request of the Town Attorney's office in accordance with §C6-2 of the Town Charter, recommend a lease between the Town of Westport and Christopher Rosenfield for property located at 260 Compo Road South, known as Cabin 1."
 - a. Motion by L. Caney, second by J. Tooker. Vote was unanimous 6-0-0
- 6. Approved the request of the Superintendent of Schools by authorizing the expenditure of \$80,870.29 from the Board of Education Carryover Account to cover the cost of additional mold remediation incurred at Coleytown Middle School so as to meet the conditions necessitated by the terms of the Memorandum of Agreement dated August 31, 2015, between the Board of Education and the Board of Finance creating the Carryover Account.
 - a. Motion made by M. Rea, second by J. Tooker, Vote was unanimous 6-0-0.

At 9:58 a motion to extend meeting beyond 10:00 P.M. was made by J. Hartwell, second by L. Caney-Vote unanimous 6-0-0

7. Rescinded the resolution adopted January 4, 2017 whereby the Board approved an appropriation request in the amount of \$1,265,000 along with bond and note authorization to the Municipal Improvement Fund Account #30508810-500140 for dredging sediment from Compo Basin and the approach channel, the amount of \$1,265,000 along with bond and note authorization to the Municipal Improvement Fund Account #30508810-500140 to be for a 15 year bond term paid by slip holders at 100%. Motion to rescind made by L. Caney, second by J. Tooker. Vote was Four (4) FOR (S. Gordon, J. Tooker, L. Caney B. Stern vs Three (3) Against (J. Hartwell, J. Westphal , M. Rea). S. Gordon joined by phone for this item only.

8. Denied the request of the Director of Parks and Recreation, for an appropriation in the amount of \$1,265,000 along with bond and note authorization to the Municipal Improvement Fund Account #30508810-500140 for dredging of approximately 20,727 CY of sediment from Compo Basin and the approach channel.

Motion to approve made by B. Stern, second by J. Tooker. Vote was 2 **FOR** (Stern, Tooker) – 4 – **AGAINST** (Rea, Caney, Westphal, and Hartwell). Motion defeated 2 vs 4.
