MINUTES

1. Item #1 was presented by Jennifer Tooker. There was a minor revision. Upon motion by Melissa Kane, seconded by Jim Marpe and passing by a vote of 3-0, it was:

RESOLVED, that the minutes of the Board of Selectmen's public meeting of December 13, 2017 and the Board of Selectmen's special public meeting of December 22, 2017 are hereby APPROVED.

APPROVE REVISIONS TO PROCEDURES FOR USE OF TOWN-OWNED PROPERTY, FACILITIES AND/OR PUBLIC ROADWAYS

2. Item #2 was presented by Assistant Town Attorney Eileen Flug. Ms. Flug explained the reasons for revisions - mainly for ease of administration, to include the Wakeman Town Farm, clarify the status of the organizations that apply, and to have requirements for insurance and hold harmless separate from the application. One major revision is to eliminate the need for review by the Board of Selectmen for those applications for events that have been approved for two years in a row and have no significant changes in scope (attendance, route, etc.) or complaints. This policy is consistent with the Parks & Recreation's application. Upon motion by Jennifer Tooker, seconded by Melissa Kane and passing by a vote of 3-0, it was:

RESOLVED, that the Procedures for Use of Town-owned Property, Facilities and/or Public Roadways, as revised, is hereby APPROVED.

APPROVE REQUEST FOR VARIANCE OF THE TOWN DRIVEWAY ORDINANCE FOR PROPERTY KNOWN AS 190 HILLSPOINT ROAD

3. Item #3 was presented by the applicant Kevin Pleiter, owner of the subject property, and Peter Ratkiewich, Director of Public Works. Mr. Ratkeiwich provided the engineering perspective that maintains that the proposed driveway placement will be safer than the current configuration. As a result, it is necessary for the Board to approve a variance of the Driveway ordinance. Mr. Pleiter agreed to the terms of the associated agreement to ensure the Town was held harmless for any liability or claims resulting from the granted waiver. 4. Item #6 was presented by Director of Parks & Recreation Jen Fava and Parks & Recreation Commission Chair Charlie Haberstroh. Ms. Fava and Mr. Haberstroh explained the reasons for providing clarity to some of the policies and procedures associated with the Town beaches. They stated that the public would be informed of the rules and regulations upon entrance to the beaches via handouts and new signage, as well as increased enforcement. Both Ms. Fava and Mr. Haberstroh indicated that such a review was warranted on a yearly basis and that the Department and the Commission intended to insure that process occurred going forward. Upon motion by Melissa Kane, seconded by Jim Marpe and passing by a vote of 3-0, it was:

REVISED PARKS & RECREATION RULES AND REGULATIONS:

The following rules and regulations currently exist:

General Rules for Parks and Recreation Property

- Erecting a tent or canopy 10' x 10' or larger is prohibited without prior written permission of the Parks and Recreation Department.
- ➤ The use of barbeque grills shall be permitted in designated areas only, and shall be properly extinguished before departure. The building of bonfires or campfires is prohibited except in conjunction with Parks and Recreation Department sanctioned events. (Also see change listed under modification of Beach Rules)

Beach Rules

No person shall engage in any athletics, games or contest except swimming at any public beach, except in areas designated for that purpose by the Westport Parks and Recreation Department.

The following rules and regulations currently exist, but modification is proposed:

Parking Emblems, Handpasses and Permits

Non-residents who would not otherwise be eligible for a parking emblem who apply after Labor Day of one year will be offered the opportunity to purchase a parking emblem for the following year at an approved non-resident fee. (Sales limited to 600 emblems)

To be changed to:

Non-residents who would not otherwise be eligible for a parking emblem may purchase a parking emblem on a first come-first served basis at an approved non-resident fee. (Sales limited to 350 emblems)

Consumption of Alcohol/Glass Containers

Alcoholic beverages are prohibited at Compo Beach facility (parking lots, athletic fields, basketball courts, beach front area, and grass areas) without a prior written permit issued by the Parks and Recreation Department, the exception being the South Beach picnic area.

To be changed to:

- Alcoholic beverages are prohibited at Compo Beach facility (parking lots, athletic fields, basketball courts, skate park, pickleball courts, beach front area, and grass areas) without a prior written permit issued by the Parks and Recreation Department, the exception being the South Beach picnic area.
 - ➤ Glass bottles and containers are prohibited on all beaches, parking lots, parks, athletic fields and any other property under the jurisdiction of the Parks and Recreation Department.

To be changed to:

Glass bottles and glass containers are prohibited on all beaches, parking lots, parks, athletic fields and any other property under the jurisdiction of the Parks and Recreation Department.

Beach Rules

➤ Vehicles are prohibited from beachfront areas.

To be changed to:

Non-official vehicles are prohibited from beachfront areas.

> Swimming shall be allowed in designated bathing/swim areas only. Areas are designated by red and white swim buoys. Watercraft including windsurfers and aircraft are prohibited from swim area.

And

The use of flotation devices (other than a recognized boating craft in designated area) is permitted only in the designated bathing/swim area off South Beach. This activity may be suspended if conditions make activity unsafe as determined by the Westport Parks and Recreation Department.

To be changed to:

Swimming shall be allowed in designated bathing/swim areas only. Areas are designated by red and white swim buoys.

And

The use of flotation devices such as boogie boards and skim boards are permitted only in the designated bathing/swim area off South Beach. Use of watercraft including, but not limited to, kayaks, paddle boards, kite surfers, windsurfers and aircraft are permitted only in the designated non-bathing/swim area off South Beach.

The use of barbeque grills shall be permitted in designated areas only, and shall be properly extinguished before departure. The building of bonfires or campfires is prohibited except in conjunction with Parks and Recreation Department sanctioned events.

Under General Rules to be changed to:

The use of barbeque grills shall be permitted in designated areas only, and shall be properly extinguished before departure. Open burning is prohibited unless authorized by both the Parks and Recreation Department **and** the Fire Marshal's Office.

Under Beach Rules to be changed to:

The use of barbeque grills at Compo Beach shall be limited to South Beach only and shall be properly extinguished before departure. Open burning is prohibited unless authorized by both the Parks and Recreation Department **and** the Fire Marshal's Office.

The following rules and regulations are proposed:

Parking & Traffic

➤ Daily pass parking a Compo Beach is permitted only in designated area. Violators will be subject to a parking ticket per day.

- > Bicycle riding prohibited from walkways and boardwalk areas.
- Music must be kept to a reasonable level, so as not to encroach on other patrons.
- Flotation devices are prohibited in designated bathing/swim areas with the exception of Coast Guard approved Personal Flotation Devices (PFD) Type I, II, or III. A child using a personal flotation device must be accompanied in the water by an adult.
