#### MINUTES

1. Item #1 was presented by Jennifer Tooker. There were no revisions. Upon motion by Jim Marpe, seconded by Melissa Kane and passing by a vote of 3-0, it was:

### APPROVE AFFILIATION AGREEMENT BETWEEN THE TOWN OF WESTPORT AND THE UNIVERSITY OF NEW HAVEN FOR DIETETIC INTERNSHIP AT WCSA

2. Item #2 was presented by Holly Betts, R.D., WCSA Program Manager. Ms. Betts described the program and the benefits to the enrolled interns. The agreement is a renewal from the previous year. Upon motion by Jim Marpe, seconded by Melissa Kane and passing by a vote of 3-09, it was:

RESOLVED, that the Affiliation Agreement between the Town of Westport and the University of New Haven as it relates to the Dietetic Internship Program at the Westport Center for Senior Activities is hereby APPROVED.

#### APPROVE AGREEMENT BETWEEN THE TOWN OF WESTPORT AND CATHOLIC CHARITIES OF FAIRFIELD COUNTY, INC. FOR DISHWASHER AT WCSA

3. Item #3 was presented by Sue Pfister, Director of the Senior Center. Ms. Pfister explained that this agreement is a two-year renewal; and that staff and residents were very happy with the arrangement. Upon motion by Melissa Kane, seconded by Jim Marpe and passing by a vote of 3-0, it was:

4. Item #4 was presented by Deputy Fire Chief Mike Kronick. DC Kronick provided background to the system and how it could be utilized in the future to provide town-wide notifications. Police Chief Foti

Koskinas provided background with the PD's experience with the company as well as its intention to expand the usage between the Police and Fire Departments. The Board expressed interest in how it may be utilized in the future for options outside of emergency notifications (e.g. town-wide events, school use, etc.) and was assured that those types of notices could be sent. DC Kronick explained that the system for mass communication was less expensive and more modern than the current CodeRed. Assistant Town Attorney requested that the original agenda item be revised to reflect that the contract was subject to the Town Attorney's final review. That revision is noted in the resolution. Upon motion by Melissa Kane, seconded by Jim Marpe and passing by a vote of 3-0, it was:

RESOLVED, that the Master Services Agreement between the Town of Westport and Everbridge, Inc.- Nixle as it relates to the interactive communication services for emergency notifications is hereby APPROVED, subject to the Town Attorney's final review.

## APPROVE AWARD OF CONTRACT FOR BID #19-938T TO LOWEST BIDDER (FGB CONSTRUCTION)

5. Item #5 was presented by Director of Public Works Peter Ratkiewich. Mr. Ratkiewich stated that this contract was for approximately 5 miles of paving town roadways during the upcoming fall season. The bids were received on September 7, 2018, with FGB Construction submitting the lowest bid. The resolution was revised to reflect the award to the low bidder. Upon motion by Jim Marpe, seconded by Melissa Kane and passing by a vote of 3-0, it was:

RESOLVED, that the Award of Contract, (Bid #19-938T), Pavement Preservation and Repairs – Fall 2018, to FGB Construction Co., Inc., of Norwalk CT in the amount of \$87,085.55 is hereby APPROVED.

## APPROVE AGREEMENT BETWEEN ACCELA, INC. AND THE TOWN FOR LAND USE SOFTWARE SUBSCRIPTION SERVICES

6. Item #6 was presented by Operations Director Sara Harris. Ms. Harris noted that the agreement provides a software solution to the land-use permitting process. Accela offers a workflow improvement to the current process which will benefit the land use departments; provide efficiencies and coordination among multiple departments, and; afford customers/residents the ability to track applications throughout the land-use permitting process. Doug LoMonte of Berchem Moses stated that the contract passed legal review. Upon motion by Jennifer Tooker, seconded by Melissa Kane and passing by a vote of 3-0, it was:

RESOLVED, that the Master Service Agreement between Accela, Incorporated and the Town of Westport as it relates to the purchase of land use software subscription services is hereby APPROVED.

### APPROVE AGREEMENT BETWEEN THE TOWN OF WESTPORT AND INTEGRATION PARTNERS

7. Item #7 was presented by IT Director Eileen Zhang. Ms. Zhang explained that the ongoing infrastructure upgrade will provide increased security, speed and reliability to the Town's IT services. Assistant Town Attorney Eileen Flug confirmed that the amendment passed legal review. Upon motion by Jim Marpe, seconded by Melissa Kane and passing by a vote of 3-0, it was:

RESOLVED, that the First Amendment to the Service Agreement dated September 20, 2016 between the Town of Westport and Granicus, LLC is hereby APPROVED.
