Board of Selectmen September 26, 2018 APPROVED MINUTES

The Westport Board of Selectmen, Traffic Authority and Water Pollution Control Authority held a public meeting on Wednesday, September 26, 2018 at 9:00 a.m. in Room 307/309 of the Westport Town Hall. In attendance were Jim Marpe, Jennifer Tooker, Melissa Kane (via telephone), Eileen Flug, Sara Harris, Eileen Zhang, Peter Ratkiewich, Rick Giunta, Ned Batlin, Sam Arciola, Foti Koskinas, Ira Bloom, presenters as noted in the minutes, and Eileen Francis, recording secretary.

MINUTES

1. Jennifer Tooker presented Item #1. Ms. Tooker noted an error in the numbering sequence of Items 3 and 4, and the revision is corrected in the approved minutes of September 12, 2018. Upon motion by Jim Marpe, seconded by Melissa Kane and passing by a vote of 3-0, it was:

APPROVE REQUEST FOR PERMISSION FROM THE WESTPORT ASTRONOMICAL SOCIETY TO PAVE DRIVEWAY AT 182 BAYBERRY LANE

2. Franco Fellah and Kevin Green representing the Westport Astronomical Society presented Item #2. Mr. Fellah and Mr. Green explained that the Astronomical Society would be paying for the paving (adjusted to include the driveway ONLY), the paving of the dirt driveway would improve plowing capabilities, and encourage participation at the facility. Public Works Director Peter Ratkiewich noted that Nado was a reputable contractor and that the design was acceptable to the Public Works Department. Assistant Town Attorney Eileen Flug requested a revision stating that appropriate evidence of insurance and a Hold Harmless agreement would be provided. Upon motion by Jim Marpe, seconded by Jennifer Tooker and passing by a vote of 3-0, it was:

RESOLVED, that pursuant to Sec. V. of the Lease Agreement between the Town of Westport and the Westport Astronomical Society, Inc., dated May 2, 2016, and contingent upon receipt of a Hold Harmless and evidence of insurance acceptable to the Public Works Department and Town Attorney's Office, the request for permission to pave the driveway at the townowned property known as 182 Bayberry Lane is hereby APPROVED.

3. Director of Public Works Peter Ratkiewich and Deputy Police Chief Sam Arciola presented Item #3. The presenters noted that this reconstruction is a continuation of the improvements being done at the Railroad Station; they provided a possible timeline once the design was provided, and; they have been pleased with the work of CLA Engineers. 4. Rick Giunta, representing the Parks & Recreation Department, and Ned Batlin, President of the Police Athletic League presented Item #4. They noted that there is little contractual change to the Agreement from previous years with the exception of its 5-year term (previous agreements were for 1 year terms). Assistant Town Attorney Eileen Flug stated that it passed legal review. The Board expressed its appreciation to PAL for running the rink. Upon motion by Jim Marpe, seconded by Jennifer Tooker, and passing by a vote of 3-0, it was:

5. Operations Director Sara Harris and IT Director Eileen Zhang presented Item #5. Ms. Harris and Ms. Zhang described the services that ZedIT would be providing related to the software integration, implementation and workflow process associated with the Land Use Permitting software from Accela, Inc. Attorney Doug LoMonte of Berchem Moses stated that the agreement passed legal review and he was comfortable with the terms. Upon motion by Jim Marpe, seconded by Jennifer Tooke and passing by a vote of 3-0, it was:

RESOLVED, that the Software Consulting Services Agreement between Zed IT Solutions and the Town of Westport as it relates to land use software project implementation, management and training services is hereby APPROVED.

UPDATE TO THE TOWN'S REQUEST TO THE FEDERAL RAILROAD ADMINISTRATION (FRA) TO MODIFY ITS NORTHEAST CORRIDOR (NEC) FUTURE RECORD OF DECISION REFERRING TO THE GREEN'S FARMS RAILROAD STATION. DISCUSSION ONLY

7. Town Attorney Ira Bloom and First Selectman Jim Marpe presented an update to the Federal Rail Administration's NEC FUTURE Record of Decision (ROD) that referred to Westport's Green's Farms Railroad Station. Mr. Bloom and Mr. Marpe provided background to the process and the timeline of Westport's involvement, including discussions with federal officials responsible for the ROD, and the reference to Green's Farms Station in its conceptual plans. Mr. Bloom indicated that there was "positive" news. While it would not be possible to "revise" the final ROD, as presented by the Federal Rail Administration, a letter from Rebecca Reyes-Alicea, FRA Northeast Corridor Program Advisor, clarified that the reference to the Green's Farms Station as a possible station along the NE Corridor was "for illustrative purposes" only. The Board requested that Attorney Bloom and Mr. Marpe reply to Ms.
