# CT PROBATE COURTS: DID YOU KNOW?



**Types of Matters On Our Docket:** 

Note: These fact patterns do not represent specific cases in the court; rather, they are representative samples of the types of matters presented to the Probate Court.

1. A mother died. At the time of death, she was living with her son. Her daughter accuses the son of mismanaging the mother's finances while she was alive. In probate court, the

daughter objects to the admission of the will on the grounds of undue influence and asks the court to compel an accounting under the power of attorney in which the son, as his mother's agent, spent their mother's money.

- 2. A woman fell in her home and died, unexpectedly. She left no will, and has no parents, spouse or children. She owns property, including her house. A distant cousin petitioned the court for custody of her remains for cremation but does not wish to be administrator of the estate. The court must appoint an administrator whose first task will be to do an heir search to ascertain who is entitled to inherit the estate.
- 3. A child is expected to receive millions of dollars from a medical malpractice lawsuit. The court must approve the settlement terms of the lawsuit, appoint a person to be guardian of the funds until the child reaches the age of 18, and oversee the investment of the funds during that period of time.
- 4. A 25 year old man was diagnosed with paranoid schizophrenia. He was threatening his family and claimed he is the reincarnation of Jesus Christ. He refused to eat. He was admitted to the psychiatric ward on an emergency basis for no longer than 15 days. The hospital petitioned the court to commit him for a longer duration.
