Open Space

West Parish

Silent Grove

Tree Ordinance is on First Selectman's desk. This ties into beautification of Post Road. Many other towns in Connecticut have tree protection ordinances. This ordinance would give the Tree Warden the ability to care for and protect trees on Westport public property.
