To take such action as the meeting may determine to approve the request for a waiver of the Westport Policy on Encroachments on Town Property as it relates to a portion of a stone wall and shrub plantings to be located within the Town right-of-way on property known as 371 Greens Farms Road, contingent upon compliance with recommendations from relevant Town departments.
- 3. To take such action as the meeting may determine, acting in its capacity as the Local Traffic Authority, to review the Traffic Access and Impact Study Report, dated June, 2018, as it relates to the proposed Westport Weston Family YMCA Expansion; and further, to authorize James S. Marpe, as Chair of the LTA, to notify the State of Connecticut OSTA of its concurrence with the assessment that there would be no adverse impact associated with the proposal to any state or town highways or roads as outlined in the report.
