
Meeting Minutes Prepared by: Joseph Fuller Jr.

The following was reviewed:

- The previous Minutes of Meetings dated May 11, 2011 were briefly reviewed. It was noted that not 1. enough committee members were present to adopt those Minutes. This item was tabled until the next meeting on July 13, 2011.
- 2. The SWOT Analysis, Strategic Plan, and summary notes was also not reviewed and adopted for reasons above.
- J. Klinge noted that the HVAC system replacement for the Town Hall Building had funding passed for the 3. project on June 7, 2011. All parties note that it should be reviewed whether diffusers and cleaning of the duct work was part of the overall project scope of work. The Maintenance Committee recommended reviewing the final project scope.
- All parties reviewed an old list of Town owned buildings and started to update same. It was agreed that 4. only major buildings would be included, and not pump stations, guard shacks and other such minor facilities. (See attached edited list for review and comment). Once it has been finalized, a new document will be prepared and distributed. In the meantime, it is still "a draft."

- 5. J. Fuller reviewed various reports from 1995/1998 and others, and noted these require updating. The Chairperson shall review the possibility of acquiring some funding for renewal and updating of previous Town owned building reports. If funding is not available, as discussed, the Maintenance Committee shall undertake updating all of the reports in-house. Some buildings have been completed. Others require further investigations.
- Files were returned to J. Broadbin's office. 6.
- 7. A discussion took place with regard to again obtaining an intern for some data entry work and paperwork aspects of the Maintenance Committee. It appears, after contacting Staples HS, that currently no interns are available for this work. Suggestions were made to try the community college or Fairfield University for same.
