1. Jennifer Tooker presented Item #1. There were no revisions. Upon motion by Melissa Kane, seconded by Jim Marpe and passing by a vote of 3-0, it was:

3. Dewey Loselle, Chair of the Downtown Plan Implementation Committee, presented Item # 3. Mr. Loselle provided background and some historical perspective about Ms. Schultz: her life, career, and contributions to the community, both locally and internationally through her involvement in World War II. He stated that the DPIC was in favor of this naming, and requested that the Board approve it and forward the recommendation to the RTM. Assistant Town Attorney Eileen Flug noted that the address of the parking lot on Elm Street was 36 Elm Street, and the originally item was revised. 5. Tree Board Member Ed Picard presented Item #5.
