TREE WARDEN REPORT

RFP for Landscape architect plan for LWA is out and bids are in

31 Sylvan Road North-Trees cut down without authorization, a consultant has been called in to provide a full assessment. Bruce calculated preliminary numbers into 6 figures. The town lawyers, Bertrum, Moses & Delvin have the information and will handle this case. Work has been stopped till violations have been corrected.

While unfortunate this will provide us with opportunity to publicize town policies regarding trees in the public right of way.

In town our Notable Trees have a value of possibly millions of dollars.

Tree Removals and Plantings

Eversource removed 10 trees on Sylvan. These were replaced. 40 trees were planted last year.

School bus hit tree that was actually in Norwalk.

Morningside – large tree was removed. Will replace, but with regular planting not individually.

Earth Animal – wants to pay for trees for Earth Day/Arbor Day April 24

Selectman Jim Marpe wanted more information on tree protection ordinance. Dick Fincher stated that the ordinance would help the Tree Warden with enforcement. It follows state statute defining tree management rules. It would allow Westport to qualify as a Tree City USA opening up grant opportunities. The state of Connecticut allows the Tree Warden to set town regulations regarding trees. Regulations would be separate from ordinance and the tree warden would work with the town attorney (Eileen Flug) to set appropriate regulations regarding town owned trees.

Marci Caporizzo would like the Tree Board to have education sessions, possibly working with schools on a tree project.
