- 3. To take such action as the meeting may determine to approve a *Certificate of Appropriateness Application* dated December 2, 2011 for the proposed repairs to the chiseled and painted letters above the entrance door at **90 Post Road East**, the old Town Hall, c. 1909, located in the Jesup Road Historic District. **APPROVED**
- 4. To take such action as the meeting may determine to approve a *Certificate of Appropriateness Application* dated December 2, 2011 for the proposed removal of the night depository opening in the rear façade at **90 Post Road East**, the old Town Hall, c. 1909, located in the Jesup Road Historic District. **APPROVED**
