DID YOU KNOW?

Probate Courts and QUARANTINE:

- If a person wants to appeal an order of vaccination, isolation or quarantine, the appeal is heard in Probate Court.
- The form is available here.
- If a person is unable to pay for counsel, the state will pay for the attorney.
- The order is made after the Governor has declared a state of public emergency or the Department of Public Health has issued an order.

New Uniform Trust Code In Effect in Connecticut

As of Jan 1, CT has adopted its own Uniform Trust Code, which is not exactly the same as other states. (P.A. 19-137)

Among the important changes:

- 1. Significant expansion of Probate Court jurisdiction over intervivos trusts.
- 2. If all relevant parties consent, the court may approve the modification or termination of a trust even if the modification or termination is inconsistent with a material purpose of the trust (See Section 31)
- 3. The court can terminate a trust or remove a trustee if it finds that the value of the trust property is insufficient to justify the cost of administration relative to the material purposes of the trust. (Section 35 b)
- 4. Expanded notice requirements to beneficiaries (Section 63)

-----Types of Matters On Our Docket:

Note: These fact patterns do not represent specific cases in the court; rather, they are representative samples of the types of matters presented to the Probate Court.

1. A young woman who lives in our district died in France. She wrote her will on her deathbed but it was missing the "self-proving affidavit" that we require. The probate court is asked to admit the will anyway and will look to the law to determine whether it can be admitted.

- 2. A middle-aged woman has developed bipolar disorder with psychosis, which means that she has lost touch with reality. Her family has abandoned her. The neighbors call 911 because of her behavior, which they fight menacing and scary. The local psychiatric hospital admits her on a 15 day stay. On day 6, she requests a hearing to be discharged. The court will hear the matter within 72 hours to decide if there is probable cause to believe she is dangerous to herself, others, or gravely disabled. If so, she must stay.
- 3. A boy is being raised by his grandmother as his legal guardian because his mother was addicted to drugs. There is no father in the picture. After years of sobriety, the mother petitions the court to have her full legal rights restored. The court will decide the matter after a full evidentiary hearing.
- 4. Many, many people are petitioning to officially change their name because if there are any inconsistencies in identifying documents, getting a new "REAL ID" at the DMV is a big pain in the neck.
