



There are several directions we could go in pursuit of incorporating more Equity in our work. A spectrum to consider:


- From left to right = From a tighter focus on environmental sustainability to a broader definition of sustainability that includes economic and equity/social sustainability in addition to environment



iii) Structure Learnings - Update

SUSTAINABLE PRINCETON.

- 1. Ability to influence has more to do with relationships, ability to add value, and physical proximity than structure/reporting relationship.
- 2. Having influence in a Town is NOT just about top-down influence and making new governmental policy.
- 3. The Climate Action Plan drives everything.
- 4. The best way to attract volunteer help particularly high skill/high impact experts is to be incredibly specific and time-bound in the request.
- 5. 'It takes a certain temperament to succeed as a staff member in a 501c3 like ours'





Westport, CT - First Selectman Jim Marpe has announced that the Town of Westport, in cooperation with Sustainable Westport, is launching the Zero Food Waste Challenge and the opening of the Food Scraps Recycling drop-off area at the Westport Transfer Station, located at 300 Sherwood Island Connector.

The Sustainable Westport Zero Food Waste Challenge has set a goal to decrease Westport residential food waste by at least 25% over the next year. Food waste is one of the heaviest, wettest, and most expensive waste streams for the Town of Westport to process, and nearly one out of every four bags of groceries end up in the trash.

Town Announces 'Zero Food Waste Challenge'

With the goal of reducing residential food waste by 25% over the next year, First Selectman Jim Marpe announced today the opening of a food scraps, recycling drop-off area at the Westport Transfer Station.

According to the announcement, food waste is one of the heaviest, wettest and most expensive waste streams for the town to process, "and nearly one out of every four bags of groceries end up in the trash."

Dubbed the Zero Food Waste Challenge and orchestrated in cooperation with Sustainable Westport, the effort promotes three ways residents can participate.

In addition to the food scraps drop-off center, residents can pay a licensed food waste hauler to have scraps picked up curbside, or they can use the food waste for home composting.



SUSTAINABLE Tree Ordinance

On behalf of Earthplace and the Sustainable Westport Advisory Team, we respectfully request that the Tree Ordinance includes language that promotes the planting of native vs. non-native species of trees and shrubs. There is a significant difference in habitat value for insects and caterpillars that feed native birds. Here are some examples:

Attached is suggested language that could be added to the ordinance.

The purpose of this Article is:

- A. To promote and protect the public health, safety and general welfare by providing for the regulation of the planting, maintenance, protection, and removal of Trees and Shrubs on public property within the Town of Westport;
- B. To recognize and appreciate that Trees produce oxygen, capture carbon dioxide from the atmosphere, provide air purification, prevent soil erosion, control flooding, assist water purification, contribute to the quality of life by providing cooling shade, habitat and sustenance for birds and wildlife, reduced noise levels, calm traffic, improve property values and aesthetically enhance the landscape; and
- C. To protect the Town of Westport and its residents from property damage caused or threatened by the improper planting, maintenance or removal of Trees and Shrubs.

Sec. ____ PURPOSE AND DUTIES OF THE TREE BOARD

The Tree Board shall:

- A. Advise and assist the Tree Warden.
- B. Provide a written report indicating recommendations, preliminary approvals, final approvals or disapprovals for special permits and/or site plans, as applicable, as required by the Westport Zoning Regulations.
- C. Promote maintenance, restoration, survival and planting of Trees and Shrubs on Public Property.
- D. Educate the public to recognize the benefits provided by Trees and Shrubs including, but not limited to:
 - 1. Buffering noise
 - 2. Buffering unsightly views
 - 3. Improving air quality
 - 4. Preventing erosion
 - 5. Absorbing water (including flood control)
 - 6. Mitigating climate by cooling the air and providing shade
 - 7. The ecological value of native vs. non-native species of trees and shrubs
 - 8. Offering habitats to insects and caterpillars that feed native birds
 - 9. Increasing property values
