The Westport Historic District Commission held a public meeting at 7:00 p.m. on **Wednesday, August 19, 2020** for the following purposes:

1. To approve the minutes of the July 14, 2020 public meeting.
MOTION (made by Harris): To accept the July 14, 2020 minutes with correcting the error dealing with the creation of an HDC subcommittee item stating that a vote was not taken.

VOTE: Unanimously approved.
2. To take such action as the meeting may determine to oppose the issuance of the demolition permit for **39 Burr Farms** and require the full 180-day delay.
MOTION (made by Weingarten): To oppose the issuance of the demolition permit at 39 Burr Farm and require the full 180-day delay.
