1. To approve the minutes of the August 19, 2020 public meeting.

MOTION (made by Weingarten): To approve the minutes of the August 19, 2020 public meeting as amended after tape review.

2. A *Certificate of Appropriateness* application dated August 11, 2020 to build two fences and paint the house at **1 Evergreen Parkway** located in the Evergreen Avenue Local Historic District.

MOTION (made by Weingarten): To approve a *Certificate of Appropriateness* application dated August 11, 2020 to build two fences and remove paint in a fashion that does not damage the substrate at 1 Evergreen Parkway located in the Evergreen Avenue Local Historic District

- 3. A Certificate of Appropriateness application dated July 6, 2020 to build a 95 unit Assisted Living and Memory Care residence, move the house at **174 Post Road West**, demolish the house now situated at **172 Post Road West** and create parking lots and driveways associated with egress located in the Kings Highway North Local Historic District. **Withdrawn by applicant.**
- 4. To take such action as the meeting may determine to oppose the issuance of the demolition permit for **58 Turkey Hill Road South** and require the full 180-day delay.

MOTION (made by Weingarten): To oppose the issuance of the demolition permit for 58 Turkey Hill Road South and require the full 180-day delay.
