 join Town committee, but can't also be on 501c3. Current Sustainable Westport Advisory Team
 members to consider preference in advance of Oct 1 meeting.
 - A local sustainability enthusiast, Analiese Paik, was referred to the Advisory Team by Dawn Henry. She is interested in taking on a role with the 501c3 to work on the strategic plan, develop working groups, create fundraising strategy, etc. at first as a part time volunteer and then potentially as the full time Executive Director. She is will to work 50% volunteer/50% paid approximately 20 hours a week, with the understanding that funds need to be raised first.

Food waste update

• In Pippa's absence, Peter shared slides on a food waste update. Food scraps recycling is off to a great start – we're seeing a week over week increase in volume, and weight of compost doubled in the first 4 weeks. Unfortunately pickup needed to be temporarily shut down due to staff shortages from Hurricane Isaias. ZFW has access to matching funds grants from SustainableCT. NGO Sustainability is no longer picking up food scraps from residents as students returned to school. Earthplace is selling Zero Food Waste kits and implemented an intercom system to allow for continued distribution of kits during COVID.

Force is creating virtual content, and also working with the EV Club of
Connecticut to do an EV Parade on Sunday September 27th at 10am. First

at the Westport train station.

• Anti-idling- Peter B

• With more parents driving their students to school because of COVID, SW wants to encourage students within walking distance to walk; within biking distance to bike; while waiting to no idle, and to promote the message that now may be a good time to convert to electric cars. If a new car purchase or car lease is imminent, try to upgrade to automatic anti-idling feature if going full electric or hybrid is not an option. Another suggestion is to encourage neighbors to group together (safety in numbers) to bike to school. SW is striving to encourage residents not to let circumstances make this become a bad habit.
