Notice is hereby given of a Public Hearing of the Westport Conservation Commission pursuant to the Connecticut Inland Wetlands and Watercourses Act, and the Regulations for the Protection and Preservation of Inland Wetlands and Watercourses of the Town of Westport (IWW Regulations) and the Waterway Protection Line Ordinance to be held on **Wednesday**, **November 18**, **2020 at 7:00 p.m. via Zoom**.

Pursuant to the Governor's Executive Order No. 7B, there will be no physical location for this meeting. This meeting will be held electronically and live-streamed on <a href="www.westportct.gov">www.westportct.gov</a> and shown on Optimum Government Access Channel 79 and Frontier Channel 6020.
