4. Item #4 was presented by Bill Meredith, representing Sound Cyclists Bicycle Club. Mr. Meredith said that members of the Sound Cyclists club had met with Police Captain Calka and had revised the route so there would not be participants on both sides of the roadway. In addition, there usually was a 10 percent (average) of no-shows and would like to increase participant limit. Board members expressed concern about increasing the participant limit. Westport resident Matthew Murray said he had concerns about the change in the date – moved to after Memorial Day. He also expressed his concerns for increasing the number of participants. Mr. Meredith indicated that the Sherwood Island State Park was not available before Memorial

Day, and that it was safer to stage the event at the state park than the Luciano Park and have to bicycle over Bridge Street bridge. The Board requested that additional backup information from the Police Department be received prior to taking action on the request to increase the number of participants. Upon motion by Shelly A.
