Notice is hereby given of a Public Hearing of the Westport Conservation Commission pursuant to the Connecticut Inland Wetlands and Watercourses Act, and the Regulations for the Protection and Preservation of Inland Wetlands and Watercourses of the Town of Westport (IWW Regulations) and the Waterway Protection Line Ordinance (WPLO) to be held on **Wednesday, June 16, 2021 at 6:30 p.m. via Zoom.**

Pursuant to the Governor's Executive Order No. 7B, there will be no physical location for this meeting. This meeting will be held electronically and live-streamed on [www.westportct.gov](http://www.westportct.gov) and shown on Optimum Government Access Channel 79 and Frontier Channel 6020. Comments to be read during the public comment period may be emailed to [conservationcomments@westportct.gov](mailto:conservationcomments@westportct.gov). We will use our best efforts to read public comments if they are received during the public comment period and if they state your full name and address. Comments will be limited to 3 minutes. The meeting notice will be available at [www.westportct.gov](http://www.westportct.gov) posted on the Meeting List & Calendar page. Comments on Public Hearing items that do not meet these requirements will be placed in the public file but will not be read aloud during the meeting. Comments not pertaining to Public Hearing items will not be read aloud during the meeting.

The Commission shall meet to take such action under the purview of the Town's IWW Regulations and the Waterway Protection Line Ordinance as the meeting may determine with regard to the following:

**Changes or Additions to the Agenda:** The Commission may amend the agenda by a 2/3 vote to include items not requiring a Public Hearing.

**Public Hearing: 6:30 p.m.** The following applications will be "received" by the Conservation Commission subject to determination of completion. If applications are determined to be complete the Commission will proceed by opening the hearing. (At this time interested parties may be heard after being recognized by the Chairman. Written communication may be received for all applications until the public hearing is closed.)

- 1. 6 Meadowbrook Lane: Continued Application:** Application #IWW, WPL-11252-21 by Andy Soumelidis of LandTech on behalf of Ronny Ceballo for the proposed renovation to a single-family residence, new pool, pool house, septic and associated site improvements. Portions of the work are within the upland review area and the WPLO area of Muddy Brook.
- 2. 2 Timber Lane: Continued Application:** Application #IWW, WPL-11275-21 by Dean Martin, PE on behalf of CCO Habitats LLC to construct a new single family residence, a new deck and a new, 50% code-compliant septic system. Portions of the work are within the upland review area and the WPLO area of an unnamed tributary of Dead Man's Brook.

3. **59 Red Coat Road: Continued Application:** Application #IWW-11237-21 by LandTech on behalf of Kevin Dorsey to construct a new single-family residence, pool, pool patio surrounded by walls, septic and related drainage and grading. Portions of the work are within the upland review area setbacks.
4. **10 Scofield Place:** Application #WPL-11301-21 by LandTech on behalf of Jared and Danelle Gill to - construct a new single-family residence and drainage.
5. **6 Bluff Point:** Application #WPL-11313-21 by LandTech on behalf of Arthur Tauck to install and endless pool on top of an elevated deck within the WPLO area of the Saugatuck River.
