### The Call

## The Meeting

Moderator Velma Heller:

Good evening. This meeting of Westport's Representative Town Meeting is now called to order and we welcome those who are joining us the evening. My name is Velma Heller and I'm the RTM Moderator. As you know, this meeting is being held electronically. It will be live streamed on westportct.gov, and shown on Optimum Government Access Channel 79 or Frontier Channel 6020. ## Invocation, Sal Liccione, district 9:

First off, I want to thank Jeff and Velma for asking me to speak tonight. Velma, we're very glad you're back and we see that you are hopefully getting better. I want to say it is a pleasure and a privilege to serve on the RTM with my fellow colleagues who are my family and our town Board of Finance and our P&Z. We all love this town a lot and we've been through a lot in 2020 with the COVID crisis that we all came together as a team. It has been a privilege and an honor. We had to make some hard decisions and we worked to make the town better. We all love this town. Thank you Velma.

Thank you Sal. It's always good to hear from somebody who loves the town as much as you do. Thanks again. And now, the pledge of allegiance.

#### **RTM Announcements**

Rick Jaffe, district 1:

This is not my announcement. I am so happy to see Velma back that I may pay extra taxes. Not that happy...

Long time town resident and employee Patty Haberstroh is four years into her battle of her life against ALS, Amyotrophic Lateral Sclerosis. This is the disease that brought down Lou Gehrig. Baseball fans know Lou Gehrig because he is the man who played with the great Babe Ruth. He played through all kinds of injuries until ALS took him down and out. The name ALS is also called "Lou Gehrig's Disease". Many here today participated in the ALS pepper challenge in 2018 to raise funds and awareness to end ALS. The disease is still without effective treatment or cures. Patty's children Chuck, Steve and Tom are members of the Lou Gehrig Day Committee which has worked for two years to lobby Major League Baseball to have an annual day to honor Lou Gehrig and to raise awareness for ALS. After two years, while losing six of the 27 members of their committee to ALS itself, the LG4 Day Committee, four being Lou Gehrig's number, is honored to say that tomorrow, June 2, will be the first Annual Lou Gehrig Day across all Major League Baseball stadiums. The Haberstroh's came to my Rotary Club just last week and one of the things they told me is that the owners of Major League Baseball Teams do not unanimously agree that the sun will come up in the morning so to get them to agree to have a Lou Gehrig Day to raise awareness for ALS is beyond incredible. Gehrig will join Jackie Robinson and Roberto Clemente as the only three players to have a league-wide day named in their honor. The Co-Chair of the LG4 Day Committee and Westport resident Chuck Haberstroh leads the committee with ALS patient Adam Nelson. There is a web page, Ig4day.com that has all the information you'll need. Charlie Haberstroh, who is her principal caregiver, is a former member of the RTM, current Chairman of the Parks and Rec. Commission and a friend of mine.

# Matt Mandell, district 1:

Two announcements: The first, the Chamber of Commerce is holding its first live, in-person, event other than the concerts were separated, no social distancing. It will be a networking event on June 17 at 5:30 at Gilbertie's which is one of our newest members. It will be outside, beautiful gardens, and anybody is invited to come and meet other business people in a networking session. We are very happy to see the tide is turning here and us stepping gently into in-person

meetings again. This one will be outside. So, anyone who wants to come, just go to the Chamber and come. ## **Presentation**

Amy Kaplan, district 3, Chair, Library, Museum and Arts Committee:

The Library, Museum and Arts Committee met Wednesday, May 25, to consider recommending the reappointment of Jeremy Price and Andrew Wilk who are serving currently on the Library Board of Trustees. Pat Wieser, head of the library committee attended as a representative of the Board of Trustees and she voiced her full support for both candidates. Jeremy is the current Vice President working closely with the current President, Ian Bruce, and the library executive team. Andrew has been instrumental in helping to source, connect and produce much of the amazing library content that is so well received by our community. The committee agreed that both candidates are extremely qualified and we look forward to more of their service to the library and the town of Westport. We then voted unanimously 5-0 to recommend that the RTM approve the reappointment of both Jeremy Price and Andrew Wilk each to a four year term as Library Trustees.

#### Dr. Heller:

I am back and I am sorry for the interruption. I was just on the phone with the First Selectman and he has reinforced what Lou Mall just reported to you. ### Police Chief Foti Koskinas:

I understand. We have possibly two special meetings so I will wait to hear from the First Selectman as to when he is ready to go ahead with this. We will move on it as quickly as possible.

Chief Koskinas: Thank you for your consideration. Have a good night everyone.

## Wendy Batteau, district 8:

We got an interesting email as everybody knows from Kris Hamlin earlier today.

Dr. Heller: This item has been withdrawn from the agenda tonight.

### Ms. Batteau:

I thought it made some points about finances. When we get the revised proposal, what I'd like to see is the cost differential; what the difference would be according to each plan for the next couple of years if we go back to 2017 or if we just continue on with the plan that was negotiated in 2018 so maybe that could be submitted along with.

## Dr. Heller:

Wendy, I think your question is a valid question, by all means, and it is my suggestion that you present that question to the Committee Chairs so they can address it. I think it's perhaps something they can look into. Maybe it's already been looked into. It's possible that somebody already covered that territory so, by all means.

Ms. Batteau: Okay. Thank you.

The Secretary read item #2 of the call - To approve applicants to the Connecticut Neighborhood Assistance Act (NAA) Tax Credit Program pursuant to CGS 12-630aa et seq.

#### Presentation

Elaine Daignault, Department of Human Services:

This is my annual visit to you in regards to the Neighborhood Assistance Act which is a tax credit program sponsored by the Connecticut Department of Revenue Services. The RTM's role this evening is to certify that the two applicants which we received for the 20/21 Neighborhood Assistance Program including the Westport Country Playhouse and Homes with Hope, that they are, in fact, recognized non-profit community agencies in Westport. Just a little background on the Neighborhood Assistance Program: It's designed to provide funding for municipal and taxexempt organizations by providing a corporate business tax credit for businesses that make cash contribution to these entities. So, the Neighborhood Assistance Program, they provide an application; I, in turn, bring it to the RTM for approval. We send it into the Department of Revenue Services. The Department of Revenue Services essentially puts those two businesses online so businesses can make donations to them and make a tax credit. The minimum contribution for the tax credit is \$250 and the maximum contribution any non-profit or municipal entity can receive under the program is \$150,000. There are no town funds involved in this program. We're simply certifying the two non-profit agencies. The Westport Country Playhouse has actually applied for two. One is a \$14,210 request for an upgrade of their parking lot to include LED lighting and another for \$10,500 to purchase assisted listening technology for the Jason Robarts Theater and the second applicant, Homes with Hope, is applying for \$24,340 request for roof replacement for the Bacharach Community. The applications are in order. The agencies have included all of their 990 forms as required and, with your approval, I will submit them to the Connecticut Department of Revenue Services in time to meet the July 1 deadline. That's it.

#### Dr. Heller:

Thank you very much. There was a lot of detailed paperwork to go with that that we all got to review. There is no committee report.

## **Members of the Westport electorate** – no comments

Mr. Wieser read the resolution and it was seconded.

**RESOLVED:** That upon the request of the Human Services Director, pursuant to CGS 12-630aa et seq., the Westport Country Playhouse and Homes with Hope Inc. are hereby approved as programs eligible for investment by businesses under the provisions of the 2021 Connecticut Neighborhood Assistance Act (NAA) Tax Credit Program.

## By show of hands, the motion passes unanimously 33-0.

#### Mr. Liccione:

When the Compensation Committee met, all parties weren't in the room for the meeting and I heard from two parties today that really want their voices to be heard.

### Dr. Heller:

You should mention that to the Committee Chairs. That is important for them to hear.

### Mr. Mall:

Our committees, Compensation, Finance and Public Protection all had the proper document when we met on May 19. Rick Jaffe wrote an excellent committee report. I'd like to thank Rick for his hard work. He happens to be a member of all three committees and drew the short straw for writing the report. So, there is really no need for the committee to meet again. It's only necessary to get the right document into the hands of the other members of the RTM. I'm going to ask Ralph Chetcuti and Gary Conrad to work with Jeff (Dunkerton) to get the proper document that says it's the *Non-union Supervisory Pension Plan* that covers the fire and police officers that we're talking about in this revision. So, I don't expect to have another committee meeting.

### Dr. Heller:

Mr. Liccione, in response to your question, anybody who did not get a chance to speak at the committee meetings is certainly more than welcome to share their thoughts through public comment with the RTM. That is what those people should be advised. We did hear from some people through email but they are more than welcome to share their comments at the RTM meeting.

#### Mr. Mandell:

In this strange world where we're going to move forward, whether we're live, whether we're on zoom, all I can say is with a 35 minute meeting, I'm glad this was on zoom!

Dr. Heller: I'm glad you're glad. I'm hoping that we will get to see each other again soon.

Karen Kramer, district 5: Tomorrow night. Jesup Green.

#### Dr. Heller:

Jesup Green. Absolutely. But I was talking about our next scheduled zoom meeting which is June 8. Perhaps we can get everything done on June 8.
