1. Jennifer Tooker presented Item #1. There were no revisions. Upon motion by Jim Marpe, seconded by Melissa Kane and passing by a vote of 3-0, it was:

2. Captain Ryan Paulsson representing the Police Department and the Applicant presented Item #2. Captain Paulsson explained the route and the coordination with the Police Department and the organizers. Because this is a new event in Westport, the organizers are not certain of the number of participants, but Sgt. Paulsson assured that the PD will manage necessary safety guidelines for all. Upon motion by Melissa Kane, seconded by Jim Marpe and passing by a vote of 3-0, it was:

3. Parks & Recreation Program Manager Cindy Palaia presented Item #3. Ms. Palaia described the plans for the parade were the same as previous years but would not include any indoor venues such as Town Hall.
