APPROVE 2021 SUPPLEMENTAL SEWER CONNECTIONS

1. WPCA Collection System Supervisor Bryan Thompson presented WPCA Item #1 (BOS Item #2). Mr. Thompson noted that there were 179.5 units representing 19 properties who applied for and received approval for supplemental connections in 2021. The amount to be levied against these properties amounted to approximately \$178,000. Upon motion by Candice Savin, seconded by Jennifer Tooker and passing by a vote of 3-0, it was:

RESOLVED, that in accordance with Connecticut General Statutes, the final benefit assessments to be levied against properties that obtained supplemental sanitary sewer connection approval during 2021 are hereby APPROVED.
