To construct a public transient dock with multiple slips, finger walkway & ramp for boat and personal watercraft use. The dock, ramp & walkway will be lightweight material that will be delivered in sections , assembled on land and lowered into the channel by hand at low tide. Mostly hand tools will be used, in the event anything larger is needed it will be floated in. The work being done at low tide would have very little - if any - impact to the surrounding area. The shoreline is tidal and mostly comprised of small rocks and sediment.

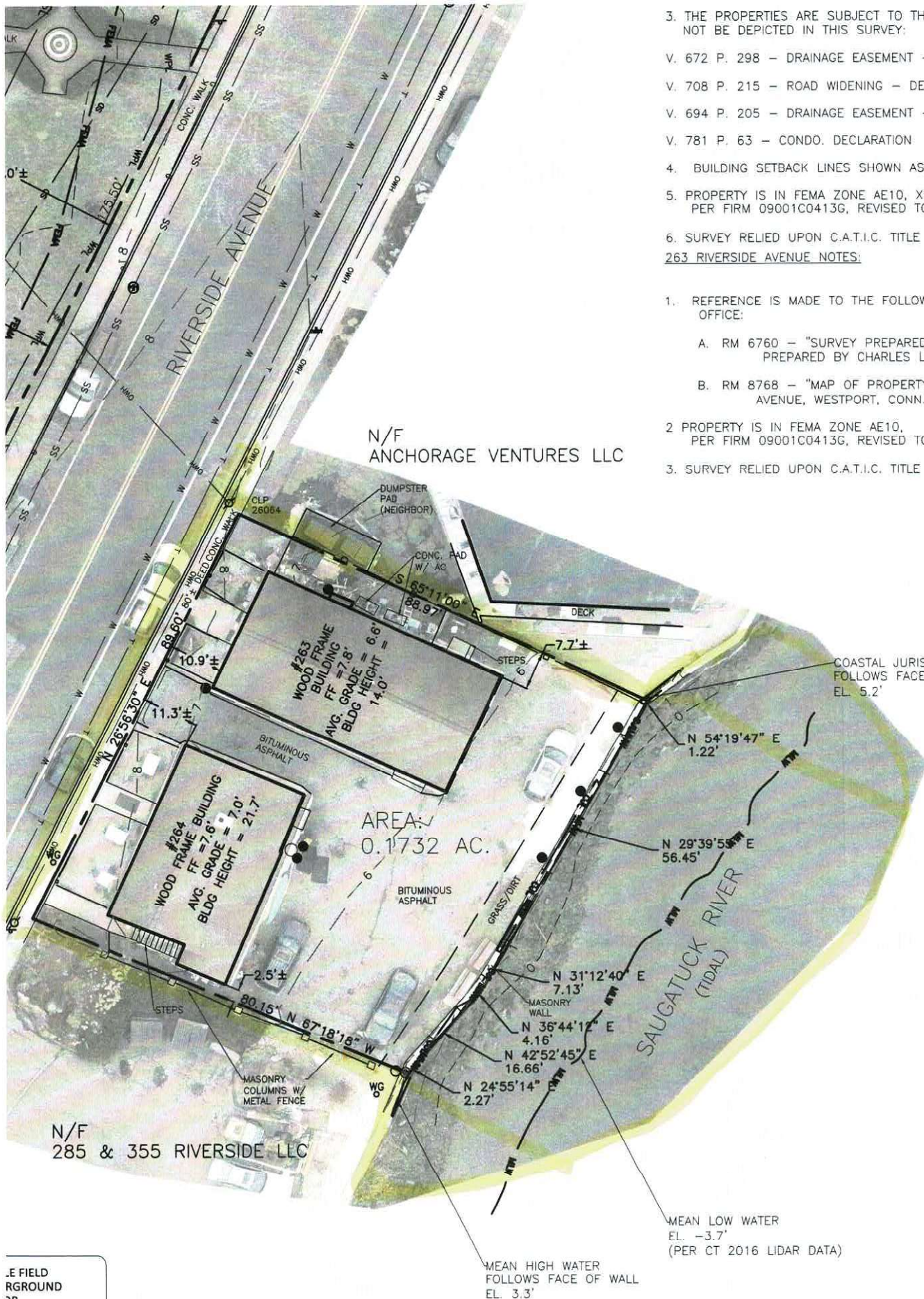

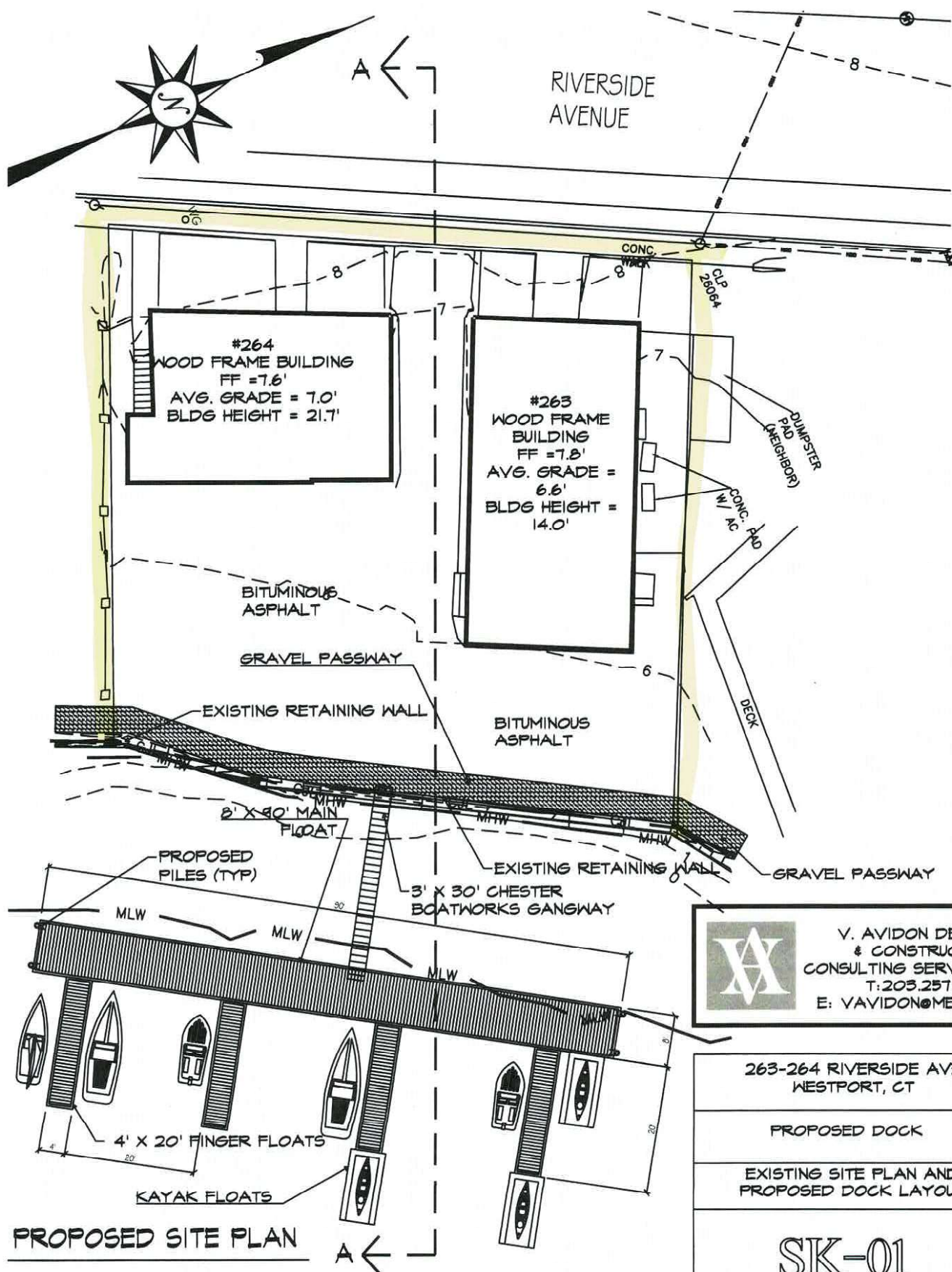

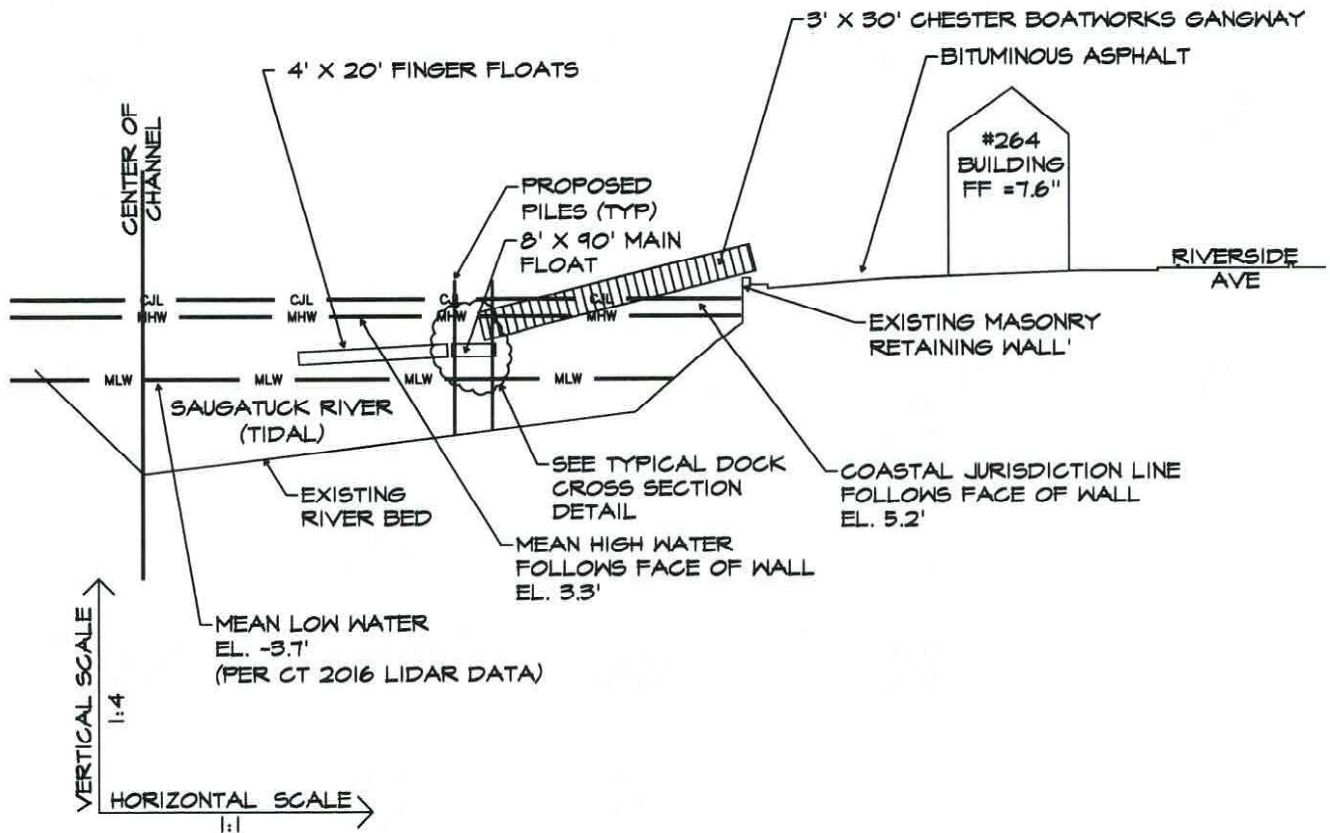

PROPOSED DOCK LAYOUT

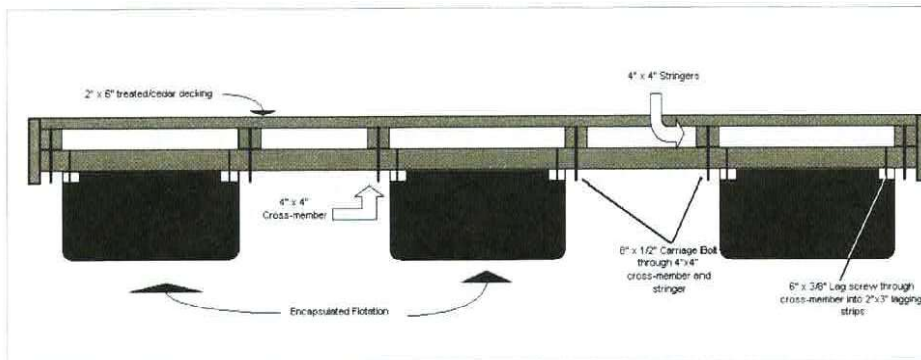

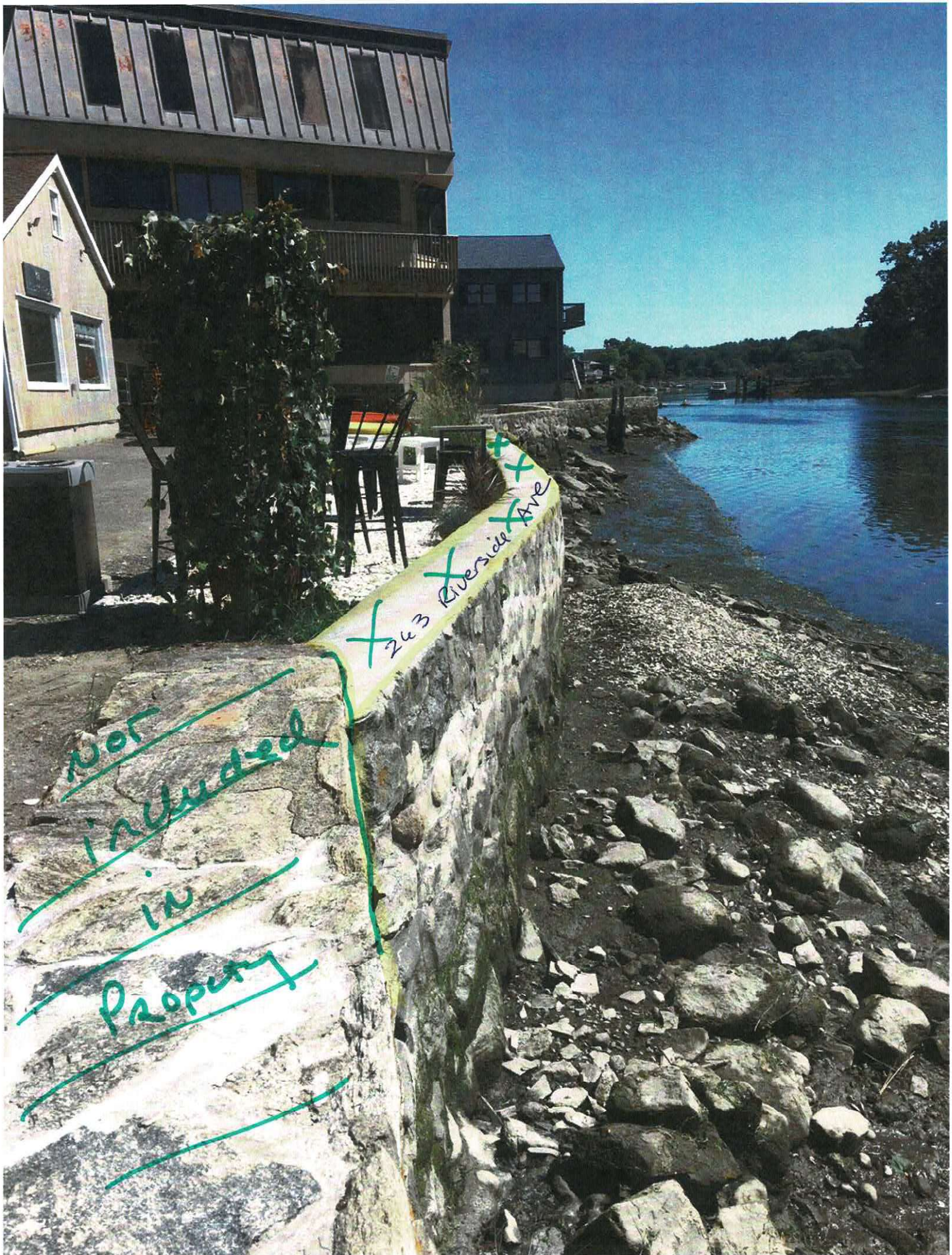

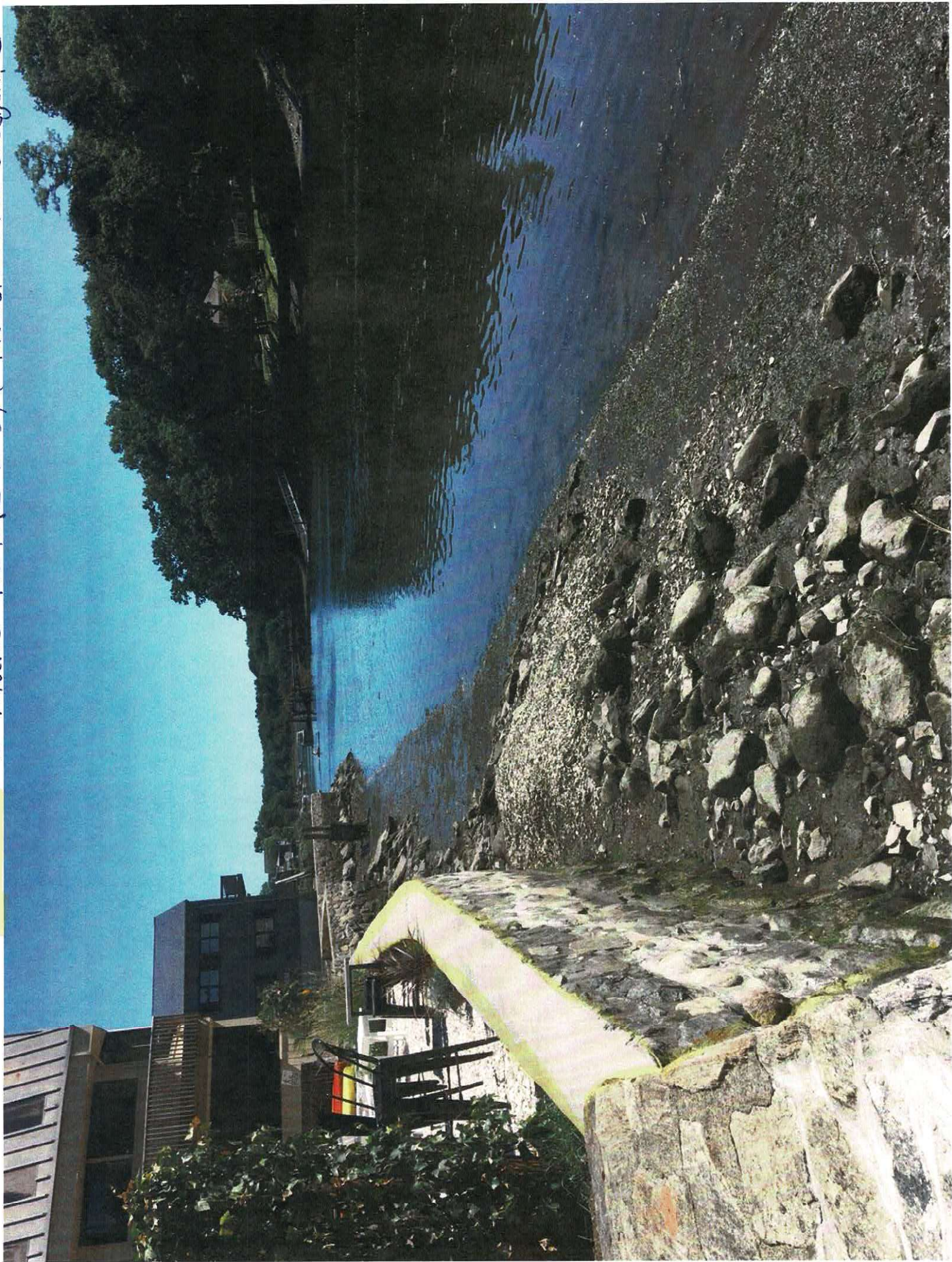

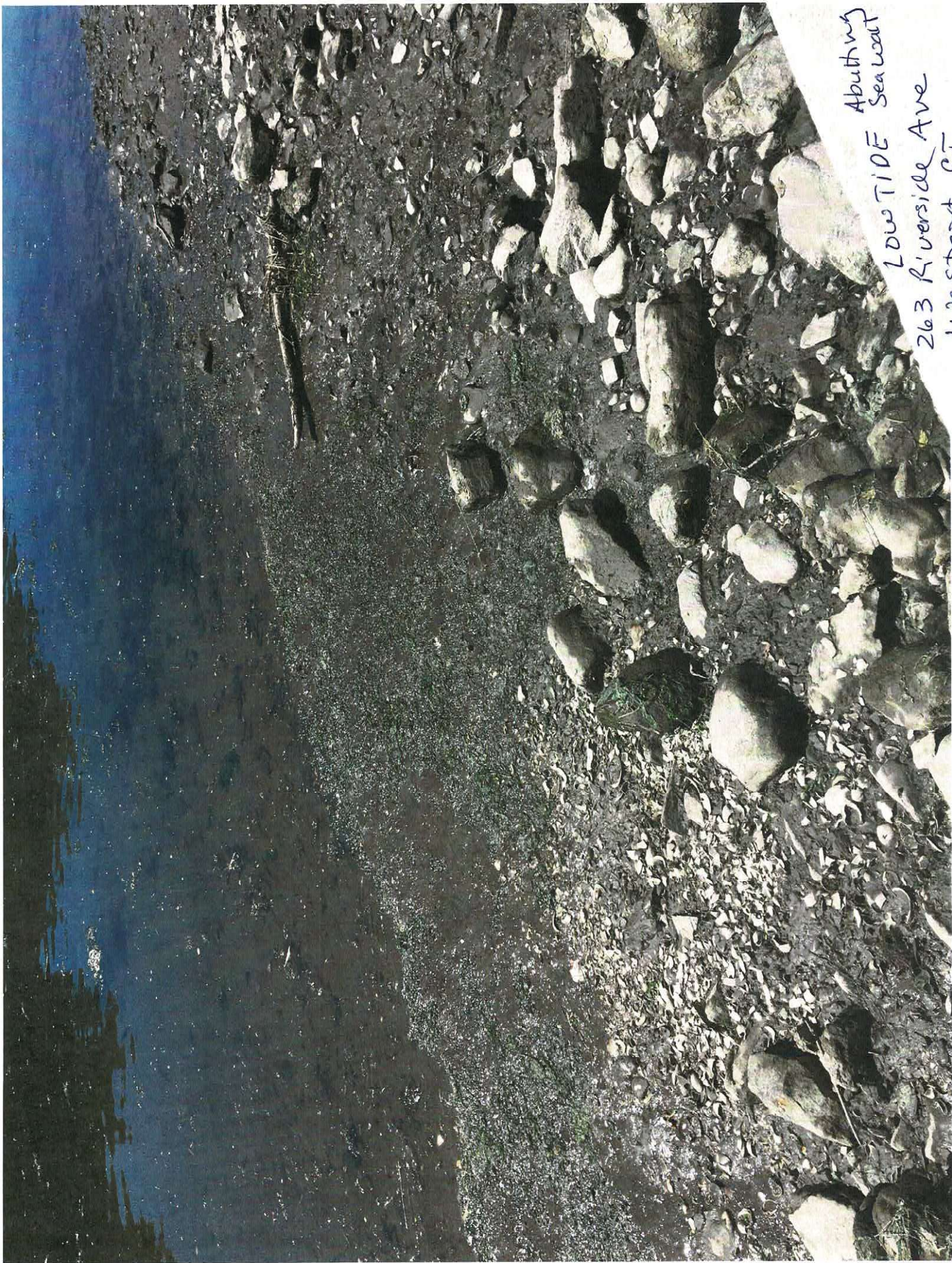

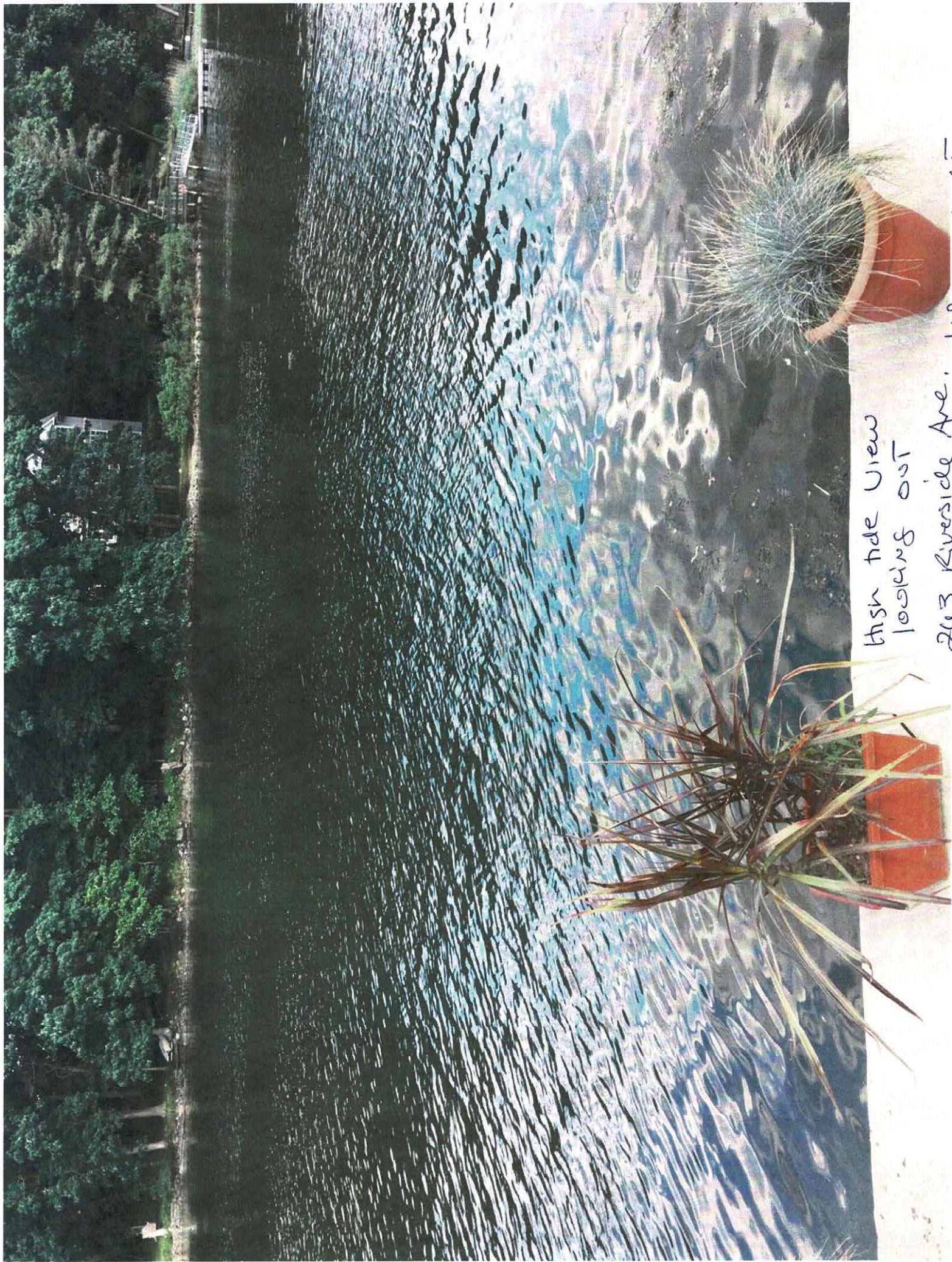
