Interrelationship of building and surroundings:

The building occupies a level site on the south side of Avery Place. It is set close to the street and faces north. Mulched flower beds surround the building, and several large trees dot the property. A paved parking area lies directly to the west of the building and a paved path leads from the main entrance to the sidewalk.

Other notable features of building or site (Interior and/or Exterior):

The building is a two-story, five-bay-by-three-bay former residence constructed in the Federal style. The asphalt shingleclad, side-gable roof has a shed dormer on the south slope. The walls are clad in clapboard with flat corner boards and rest on a brick foundation. A fluted pilaster is located on the northwest corner of the second story. The original plan was a simple rectangular block, but a one-story, shed-roof addition on the west elevation was constructed after 1940. A large addition with a salt-box connected to the east elevation by a hyphen was also built after 1940. An enclosed, flat-roof entry porch in the center of the north (facade) elevation has Ionic, fluted columns and pilasters with a wide entablature, paneled frieze and denticulated cornice. The main entrance is located in the center of the porch and consists of a wood panel door flanked by tracery sidelights with panels below. Tall, narrow tracery windows are also located on the east and west elevations of the porch. A secondary entrance is located on the west elevation of the east addition and consists of a modern paneled, partially-glazed door, The windows are primarily six-over-six, wood, double-hung sash. Windows on the first story of the facade are flanked by fluted pilasters with wide entablatures with simple friezes. Solid wood panels are located below each window. The windows on the second story and east addition feature wide, molded trim and entablatures. A Palladian window sits directly above the entry porch on the facade and consists of a central, nine-light window with wood paneling below and a scalloped, solid fanlight, flanked by solid wood panels and divided by fluted pilasters. The pilasters at capped with urns that support a molded entablature. Fanlights with prominent keys in the gable ends have late-twentieth-century, horizontal sliding windows below each. A pair of late-twentieth-century, double-hung windows are connected to the horizontal sliding window on the west elevation by a large expanse of wood panels. Large, 24-light, fixed sash windows are located on the north elevation of the east addition and hyphen. The plan of the main block appears relatively intact. Minimal alterations include the replacement of the windows in the mid-twentieth century.

Historical or Architectural importance:

According to an earlier inventory form, the house was constructed 1823 by Samuel Avery. It is visible on the 1878 view of Westport, as well as the 1879 map of the area. Due to a lack of documentation in the area, ownership history at the turn of the twentieth century is unknown. The address appears in the 1917 directory as the residence of Louis B. Toquet, and his wife, Nellie. Toquet was the president and treasurer of Toquet Manufacturing Company in Westport, which produced car parts. The Toquets lived there through the late 1940s, by which point a portion of the dwelling served as a rental property and was occupied by music teacher Mrs. M.B. Jeliffe. By 1950, the property had been purchased by R.P. Chandler, although Jellife continued to reside at the address until the mid 1950s. By 1960, the entire building was converted to offices for the consulting firm, Bruce Payne and Associates Inc. Five years later, a letter shop called The Avery Place also moved into the building. Six professional offices shared the space by 1975, including publishers Bankers Research Co. Inc., Avery Business Services, two investment firms, and three law firms. Many of these offices remained through the mid 1980s, when the building was purchased by current owners B + B Assoicates. By 1991, the building contained eleven tenants including several doctor's offices, two insurance firms, and two title service offices. Currently, the building contains Printemps Printers and the Avery Center for Obstetrics and Gynecology.

Interrelationship of building and surroundings:

The building occupies a level site on the northwest side of the intersection of Avery Place and Myrtle Avenue. It is set close to the street and faces south. Planted beds line the building's foundation and a well-kept grass lawn lies to the south and east. To the west of the house lies a patch of dense vegetation, and several other large trees and shrubs dot the property. A gravel driveway off of Myrtle Avenue leading to the former carriage house lies to the north of the house. A cast-iron fence borders the south and east edges of the lot, separating it from the sidewalk and street.

Other notable features of building or site (Interior and/or Exterior):

The building is a two-story, five-bay-by-two-bay Italianate style former residence. The shallow hip roof has a wide overhang and brick chimneys on the east and west slopes. A wide entablature runs below the roofline and contains pairs of bull's-eye windows. A square cupola is located at the ridge and has two decorative openings on each side with a wide hip roof and elaborate scroll-sawn finial. The walls are clad in clapboard with flush board on the first story of the south (facade) elevation and rest on a fieldstone foundation. The house was enlarged and remodeled in the Italianate style in the 1860s. A full-width porch with a hip roof and chamfered posts was constructed during the remodel. A bay window on the east elevation and an ell on the north elevation were also built at that time. The ell is two stories tall and two bays wide with a hip roof and brick chimney on the north slope. A one-story addition was constructed on the north end of the ell to connect it to an octagonal addition. A porch supported by tapered posts extends across the entire east elevation of the ell and one-story addition. An octagonal addition on the north elevation of the one-story addition has deep overhangs and a wide frieze containing rectangular, three-light windows. The one-story and octagonal additions were constructed in 2010. An octagonal carriage house is located northwest of the house. It is one-story tall and two-bays wide with fieldstone walls, brick quoins, and a wood shingle-clad conical roof. The main entrance is located beneath the porch in the center of the facade and consists of a wood panel door with a pedimented lintel. A secondary entrance on the east elevation of the ell consists of a wood panel door with a pediment. An entrance on the east elevation of the one-story addition consists of a wood panel door with simple wood trim. Windows primarily consist of six-over-six, wood, doublehung sash with pediments. Four pairs of full-height, three-pane casement windows are evenly spaced on the east and west sides of the main entrance on the facade. The bay window has two-over-two and one-over-one double-hung sash with panels below. The ca. 1860 plan of the house is relatively intact except for the large addition on the north elevation, which is not visible from the facade. Most of the materials are original to the 1860s remodel, but some windows and exterior cladding materials appear to be mid-twentieth-century replacements.

Historical or Architectural importance:

The Wheeler House was originally constructed ca. 1795 by Captain Ebenezer Coley for his son, Michael. The Coley's sold the property to Anne Avery and her mother, Mary Kent, in 1799. Avery married David Ripley and converted a portion of the house into a millinery shop. Through the 1830s and 1840s, the house had multiple owners. Farmin Patchin, who owned the property in 1846, built a second residence on the west end of the property. By the late 1850s, the house was purchased by Morris Bradley, who oversaw an extensive renovation that resulted in the extant Italianate villa. Bradley, who by 1870 owned \$90,000 worth of property in Westport and Weston, died in 1886 and left the house to his wife, Mary. Mary willed the property to her daughter Julia and son-in-law, Charles Wheeler. The Wheelers lived there until the early 1930s, when it passed to their son, William Wheeler. Wheeler lived in the house until his death in 1958, and operated a medical practice on the first floor. By 1960 the house was occupied by Mrs. Charlotte P. Darby, who remained there through the late 1970s. The 1980 directory listed the house as vacant, but by 1985 the property was purchased by the current tenants, the Westport Historical Society.

Interrelationship of building and surroundings:

The building occupies a level lot on the west side of Bay Street. It is set close to the street and faces east. A planted bed borders the foundation of the east elevation, and small patches of grass lawn surround the house. Tall trees line the edges of the property, and a large municipal parking area lies directly to the west of the lot.

Other notable features of building or site (Interior and/or Exterior):

The building is a one-and-one-half-story, six-bay-by-two-bay former residence constructed in the Colonial Revival style. The asphalt shingle-clad, side-gable roof has a shed dormer at the center of the east roof slope and a brick chimney at the ridge. A deep overhang with painted board fascia shelters the east elevation. The walls are clad in wood shingle. The original plan was a simple, rectangular block; but a one-story, shed-roof addition was added to the south elevation in the late-nineteenth century. A flat-roof, two-story addition on the west elevation was constructed after 1931. The primary entrance is located in the center of the east (facade) elevation of the main block of the house and consists of a pair of wood panel doors covered by metal storm doors and set in a molded wood surround. A secondary entrance is located on the east end of the shed-roof addition and consists of a wood panel door covered by a metal storm door and set in a wood frame. Another entrance on the south elevation consists of a wood panel door covered by a metal storm door. The windows are eight-over-eight, double-hung, modern, vinyl replacements with a fixed, twelve-light, vinyl sash flanked by six-light casements in the dormer. On the building's main block, the windows are crowned by heavy lintels. Beyond the basic form of the former residence, nearly all of the materials and additions appear to be twentieth-century replacements.

Historical or Architectural importance:

Based on the building's architecture, it was constructed ca. 1930 and is visible on the 1931 Sanborn map. The 1933 directory listed Mrs. A.W. Holden as the owner of the property, who remained there until about 1940. By 1946, the house was purchased by E. A. Haagenson. Haagenson sold the property to Dr. N.F. Lebhar in1948. By 1960, Lebhar, who ran his medical practice out of the building, shared the building with two other doctors and a psychiatrist. Lebhar sold the property to current owner J M K Investments in 1985, and the building now contains Bay Street Pediatrics.



Interrelationship of building and surroundings:

The building occupies a level lot on the south side of Belden Place. It is located directly to the east of the Saugatuck River and faces east. Narrow strips of grass lawn border the building's foundation and much of the rest of the lot is taken up by a gravel parking area. A wood privacy fence runs along the south side of the property.

Other notable features of building or site (Interior and/or Exterior):

The building is a one-and-one-half story, three-bay-by-two-bay, early-twentieth-century vernacular, multi-family residence. The asphalt shingle-clad, side-gable roof has a brick chimney at the ridge. The walls are clad in board-and-batten siding, with textured plywood siding in the gables. A shed roof porch on the east elevation shelters the main entrance, which consists of a glazed wood door in a wood frame. A set of staggered, two-story, two-bay-by-three-bay additions were attached to the building's east elevation ca. 1940. Each of the staggered units has its own entrance consisting of modern, vinyl, glazed doors set in vinyl frames. The windows on the main block consist of six-over-one, wood, double-hung sash. The windows on the additions are primarily one-over-one, double-hung replacement sash in wood frames with painted wood trim. On the east elevations of the additions, the windows are arranged in bands with two fixed panes flanked by one-over-one, double-hung windows. Aside from the large additions to the former residence, the plan and materials of the original block appear relatively intact.

Historical or Architectural importance:

Based on visual inspection, the building was constructed ca. 1920. It appears on the 1931 Sanborn map of the area, and the 1933 directory lists Art Extension Press Inc. and printer Francis H. Robertson Inc. at the address. The two companies remained through the mid 1960s. By 1937, several tenants occupied apartments in the building; but by 1965 the only residents were Clarence Burnett and William J. Bowman. Over the following two decades the building housed a string of tenants in four separate apartments. The property was purchased by Anna Nappa in 1984, and the 1985 directory listed three residents at the address, as well as the Center for Nutrition Education and the Machsas Outing Club. Currently, the building contains five apartments.



Interrelationship of building and surroundings:

The house is sited on a level lot at the terminus of Belden Place. It sits on the bank of the Saugatuck River and faces east. Patchy lawn surrounds the house, and several tall trees and large shrubs dot the property. A wood privacy fence runs along the north edge of the lot. A gravel parking area lies to the east of the house.

Other notable features of building or site (Interior and/or Exterior):

The building is a one-and-one-half story, three-bay-by-two-bay residence constructed in the Colonial Revival style. The asphalt shingle-clad, side-gable roof has a brick chimney at the ridge and a large shed dormer on the west slope. A second chimney is located on the south side of the west slope. The walls are clad in wood shingles with flat corner boards. A one-story, shed-roof screen porch is attached to the west elevation. A one-and-a-half-story ell is attached to the south elevation and appears to be original to the house. The main entrance is located in a shed roof extension attached to the south elevation addition and consists of a glazed wood door covered by a metal storm door flanked by full-length, decorative wood shutters. A secondary entrance lies within the screen porch and consists of a glazed wood door. The windows are primarily six-over-six, double-hung mid-to-late-twentieth-century sash set in wood frames with wide, wood trim. A small, three-over-three, double-hung window is located in the center of the shed dormer. The house has experienced minimal alterations including the replacement of some materials like the windows.

Historical or Architectural importance:

The house was constructed in ca. 1930 and first appears in the 1937 directory as the residence of Glenn R. Trumbull. By 1941, the house was occupied by commercial artist G. Sloan. Over the following decade, the house changed hands several times and by 1960 was purchased by Irving P. Hotchkiss. Hotchkiss sold the property to artist S.C. Schreiber in the mid-1960s. Schreiber remained there until 1984 when the property was bought by current owner Anna Nappa. Nappa uses the house as a rental property.
