To Whom it May Concern:

At the request of the owners, James, and Abigail Hock, I have visited the above property and reviewed the existing conditions along with the proposed new home plans.

The existing home needs to be demolished as soon as possible due the poor structural conditions from being abandoned.

Half of the existing house is built on a cold, concrete slab which will not meet current energy efficiency requirements. The existing structure is under-sized (2" x 6" rafters) with little or no insulation, the existing perimeter exterior wall sills are compromised and sit on a concrete slab, the home also has areas of past water damage.

Therefore, in view of all of these problems, it is my recommendation to take down the existing house in order to build a new home that will be esthetically pleasing to the neighborhood, meets todays living standards, meets all current structural Building code, energy requirements shown on (IRC – International Residential Code 2021).
