TREE WARDEN

Intern to help with street tree inventory was not approved by Public Works due to safety concerns.

Tree City USA application has been filed for 2022.

Growth Award application is in process, Ben has spoken to Danica about timing.

Attended CTPA Conference https://ctpa.org/ today.

There is a new foliar treatment for Beech Leaf Disease. It is not as effective for a forest or very large tree. Treatment must be timed appropriately and it is currently costly.

At the conference they also said that due to climate change and the warming of our zone, tree species for planting should be reviewed and able to tolerate warmer temperatures. Also pests of trees will be more prevalent since they can overwinter in warmer temperatures and begin life cycle earlier. Birds will not be coming earlier to eat them and this will throw off balance of nature.

Dick Stein questioned whether the Sycamore in Saugatuck could be saved. It is on state property so the state has the ultimate decision making process. We will contact our state Forestry representative to rally for the 200 ish year old tree.

Ben also mentioned that there is a form to fill out for all problem trees on state property (Post Road, etc),
