<u>Paul Fria made a motion that Homes with Hope, Inc. would continue to receive a 35% tax abatement for the properties at 90, 92-94 and 98 Saugatuck Avenue for Grand List Year 2022.</u> Seconded by Gary Conrad. Motion carried unanimously, 3-0.

Paul Fria made a motion that The Interfaith Housing Association of Westport-Weston, Inc. would continue to receive a 100% tax abatement for the property at 10 West End Avenue for Grand List Year 2022. Seconded by Gary Conrad. Motion carried unanimously, 3-0.

The Committee reviewed the financial statement for Hales Court Housing, LLC. The members asked questions and a discussion ensued. Ms. Martin confirmed that the tax abatement proceeds are still being used for the purposes set forth in the Tax Abatement Agreement.
