- SafeRides and WYC Intertwine
 - Mark Dulsky who runs SafeRides found out from Elaine what the WYC does and hopes to get his organization more involved. Julie Mombello used to run the organization, but they're getting more organized. 147 members, not very active, had to close two Saturdays this year. Making SafeRides more community based, less about Staples. PTA, Westport Pizzeria, PAL, helping us. Want to have WYC help make SafeRides more open and community-based. They have noticed differences from last year with Uber, but their goal is ultimately to get people home safely. SafeRides' wait time has increased because they've had difficulty getting volunteers. Students on the board are getting more frustrated. SafeRides is noting changes in the uses and the volunteers. SafeRides does not condone drinking, they know it happens, but they want the students to get home safely. Not only used for drinking purposes as well. Because of programs at school, students know that driving drunk is not smart. SafeRides operates at Christ and Holy Trinity Church. Try to get at least four cars, with two people in each car. Trained by police.
 - From the commission, he would like more active volunteers. Looking at statistics to pinpoint the change, but instead of getting involved for putting it on the résumé for college, but rather than being active.
