APPROVE REQUEST FOR A WAIVER OF THE POLICY ON ENCROACHMENTS ON TOWN PROPERTY FOR THE INSTALLATION OF A LANDING, RAMP AND FLOATING DOCK WITHIN TOWN PROPERTY ADJACENT TO 4 MARSH COURT

2. John Hilts, representing the homeowner, presented Item #2. Mr. Hilts described the circumstances by which the previous dock had fallen into disrepair, and that this was a replacement for that previous dock. CT DEEP has already approved the installation. Town Engineer Keith Wilberg confirmed that, although the Engineering Department is typically not in favor of granting such requests, that this circumstance warranted approval.
