The Golf Advisory Committee of the Town of Westport conducted a Zoom meeting on Monday, March 4, 2024. The meeting was called to order by GAC chairperson, Jane Dally at 7:00p.m.

Missing from the meeting was John Ehli.

**Approval of Minutes**

The minutes of the January 8 GAC meeting were approved with the exception of a small edit by Mike Durkin. He wanted the minutes to reflect that the new shoe cleaner/scrapper should not be near the 18<sup>th</sup> green and interfere with players leaving the green and slowing down play. An alternate spot should be found.
