Upon the request of the Director of Public Works, to approve an appropriation in the amount of \$50,000 from the American Rescue Plan Act (ARPA) Fund 51003310-500153 for the Rehabilitation of existing spray foam roof at the Aspetuck Health District building located at 180 Bayberry Lane.
 Upon the request of the Parks & Recreation Interim Director, to approve an appropriation in the amount of \$554,000 along with bond and note authorization to the Municipal Improvement Fund Account 30508810-500464 for the Replacement of Doubleday Tennis Court.
