APPROVE SUPPLEMENTAL SEWER CONNECTION AT #4 DAVENPORT AVENUE

1. WPCA Collection System Supervisor Bryan Thompson presented WPCA Item #1 (BOS Item #8). Upon motion by Andrea Moore, seconded by Candice Savin, and passing by a vote of 3-0, it was:

RESOLVED, that the supplemental sanitary sewer connection at #4 Davenport Avenue, contingent upon the WPCA Collection System Supervisor's letter of October 9, 2024, is hereby APPROVED.
