Upon the request of the Director of Public Works, to approve an appropriation in the amount of \$75,000 along with bond and note authorization to the Municipal Improvement Fund Account 30503310-500394-18007, for the analysis, design, permitting and preparation of construction documents for replacement of the Compo Marina North Seawall.
- 7. Upon the request of the Director of Public Works, to approve an appropriation in the amount of \$5,570,000 along with bond and note authorization to the Municipal Improvement Fund Account 30503310-500395-18008, for the funding of the construction of and for the construction engineering & inspection expenses for the replacement of the Old Road Bridge (04971) over Sasco Creek.

8. Upon the request of the Fire Chief, to approve a special appropriation in the amount of \$99,870 to the General Fund Account Funds for covering the costs related to hiring for five unanticipated openings.
